In an effort of fairness to Cliff Dwellings and those seeking reservation at this establishment the following policy has been implemented. Reservations require either a Mastercard or Visa Card to hold the reservation as indicated on page 1.

The amount for first night lodging based upon number of occupants will be charged to your credit card upon receipt of the registration form. Cancellation of reservation(s) is refundable under the following guidelines:

- Full refund requires cancellation of reservation 18 days prior to the arrival date.
- Notification less than 18 days, refund is 50%.
- Notification of less than 10 days, no refund.
